


### HOW TO REQUEST ACCESS TO CASES?

 Click on the eFile & eServe with the Office of the Administrative Law Judges (OALJ) or Board of Alien Labor Certification Appeals (BALCA) tile from the main dashboard.



2. Click on the **Request Access to Cases** button.
